This is a summary of the annual report of the Pentagon Technologies Group, Inc. Employee Health & Welfare Plan, EIN 31-1622360, Plan No. 501, for period 07/01/2023 through 06/30/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Insurance Information**

The plan has contracts with UnitedHealthcare Insurance Company, Vision Service Plan, Kaiser Foundation Health Plans, Inc. and The Lincoln National Life Insurance Company to pay Medical, Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, and Accidental Death and Dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 06/30/2024 were \$6,567,656.
